Food Vendor Trailers may set up Friday evening, please call your contact to make arrangements. Food Vendors will be located east of Broadway and Main.

You can pick up extra applications at: City Hall (Hwy 16 & Broadway (Alt. 75), American Heritage Bank – Beggs Branch or download a copy from our website.

Guidelines for Food Vendors

1. Dimensions of Trailer or Booth and Electrical requirements MUST be specified on application.
2. Vendors MUST furnish their own water hose.
3. Vendors MUST have appropriate State Health Permits.
4. Vendor location will be established by the Logistics Chairperson with regards to requested electrical and water needs.
5. Vendors requiring 220 will need to be able to hardwire straight into the electrical box – if you have any questions about this please call Crystal Simmons (918)809-5340
6. Vendors MUST submit a complete menu. **NOTE – No water or specified soda is permitted to be sold by Food Vendors – ONLY the Chamber of Commerce will be permitted to sell water, Root Beer or Sarsaparilla. ONLY Food Vendors will be permitted to sell any other Soda, Soft Drinks or Pop.**
7. Any & All food items must be individually wrapped due to Health Dept. Regulations.
8. The Chamber reserves the right to refuse any vendor it determines to be unsuitable for family entertainment, in poor taste, &/or those selling undisclosed items.
9. The Beggs Area Chamber of Commerce is not responsible for accidents or loss of merchandise. You are responsible for security at your booth.
10. Each vendor is responsible for collecting and reporting their sales tax with the Oklahoma State Tax Commission.

Food Vendors Fees

1. All Food Vendor Applications and fees must be received by June 1, 2009. If your Food Vendor Application is not approved your fees will be mailed back to you by June 30, 2009.
2. All Food Vendors will have access to electricity – must be specific on application; refer to Guidelines for Food Vendors. Fees are as follows –

With OUT water - \$75.00

With water access - \$100.00

3. In the event of a cancellation due to circumstances beyond our control your money will be returned to you.
